1. Children and Young People's Trust Board

Date of Meeting: 19th April

Name of Reps: Louise Murray and Phil East

Presentations were received on the Salford Partnership Review and from HealthWatch and Salford Young Carers on [research with young people in Salford into their emotional health and well-being needs](#). The Board agreed to support the findings of the research and some of the findings have already been incorporated into the 0-25 emotional health and well-being pathway. Work is being developed to design accessible on-line information on emotional health and well-being and schools now have a linked CAMHS adviser.

Wiktorija Matuszewska and Charlotte Godfrey attended their first meeting representing the Youth Parliament. A Young Mayor's Employment Standards Charter was reviewed and will be launched shortly.

Priority Action Reports: The report on teenage conception rates noted that since 1998 the rates have fallen by 49.1% the best ever recorded. The Anti-Bullying survey findings show that fewer young people have experienced bullying and more young people feel safe from bullying in 2015 in comparison to the previous year. More organisations took part in the annual Anti-Bullying Conference which addressed the issue of online bullying.

The Trust's annual development session was scheduled for Tuesday 7 June but then postponed. The session will focus on refreshing the Priority Actions.

An update on education outcomes showed that Early Years outcomes are improving and KS1 and KS2 outcomes in primary schools are very strong. KS4 outcomes are a key concern and fall below the national average.

It was agreed that the Seldom Heard Young People Event will go ahead in October 2016.

From 1 May, the Special Educational Needs and Disability (SEND) Inspection could take place. The Local Authority will receive five days' notice and the inspection will involve partners from Health, Social Care and Education.

The [Early Help and Neglect Summit](#) on 26 May and 8 June was promoted to all partners.

2. Salford Safeguarding Children Board

Date of Meetings: 16th May

Name of Rep: Louise Murray

An annual review of progress of the Family Nurse Partnership was presented. This service provides intensive home visiting support for young parents until their child is 2 years old and is specified by national government following an American model. There have been some strong outcomes and feedback from young parents. Progress on self-harm prevention was reviewed and as part of this a new provider, Odd Arts, were commissioned by Salford CCG to deliver self-harm workshops to schools in February and March 2016. The 'Spiralling Mind' drama was delivered to 2,040 predominantly year 9 students and was created and delivered by Odd Arts with assistance from young people from 42nd St. The performance focussed on coping methods for dealing with stress followed up by workshops and lesson plans for teachers.

An update on domestic abuse was provided which also includes a drama early intervention/prevention approach, [Black Eyes and Cottage Pie](#) about domestic abuse in intimate teenage relationships.

3. SSCB Coordination and Delivery Group

4. SSCB Training Sub Group

The Annual Training report 2015 – 2016 was on the agenda. There is a need to compare numbers from the voluntary sector attending SSCB courses with the previous year. There are no current free E learning licenses available through the SSCB. Alison fed back on the Designated Person Training which had been delivered with successful outcomes. A seminar on children affected by gang violence is being developed. SSCB Training is being categorised into levels, and CVS will need to identify where the SSCB verified training they deliver to the voluntary and community sector sits. The SSCB Basic Awareness course now covers adult safeguarding as well as children's safeguarding.

7. CSE Steering Group

Date of Meeting: 6th April 2016

Name of Reps: Wendy Priscott

CSE Steering Group is now chaired by DCI Chris Walker. Salford will adopt the GM CSE Policy, however as this is quite generic there will be a Salford pathway/operational handbook developed alongside this. The handbook will include information and recommendations from the recent CSE audit as well as from voluntary sector, education, young people and parents. The handbook will be brought to the July Steering group meeting and further details of the Operational Handbook will be shared with VOCAL once it has been completed.

CSE training has been reduced from two days to one day, and a half day basic awareness seminar has also been introduced. Due to the demand and management of this, it is proposed that ½ day Overt and Protect seminars are included each quarter which will also include updating professionals and organisations regarding the Salford Profile/progress of CSE Strategy. It was felt that although many of the training days are over subscribed many attending did not need two days of training.

The need to increase CSE awareness within the community was identified within the CSE Salford audit. DCI Walker will review this with the Avert team and through meeting with Protect. An action plan around this area will be developed within the updated CSE strategy/action plan and further discussed at the CSE steering group re roles and responsibilities.

8. Emotional Health and Well-being Partnership

Date of Meeting: 14th June

Name of Rep: Lucy Sutcliffe (Salford CVS 0-25 Project Research and Development Worker)

Lucy attended the EHWP Partnership meeting for the first time as the VOCAL CYPF Rep to this partnership. Amelia Lee from the Proud Trust gave a presentation of the draft report from the piece of work that has been looking into children and young people who are Lesbian, Gay, Bisexual or Transgender (LGBT) and how they have experienced the support and health services available in Salford. 42nd Street and the IYSS LGBT Youth Group at the Beacon centre were evidenced to be a very positive experience, GP and health services varied and CAMHS was mixed; more research will take place because it had been hard to engage the service. The recommendations so far were promising and the voice of LGBT youth was clear in the report so engagement with the service users was effective. One recommendation was to have more group work for emotional support- this would provide a good support while on a waiting list and may be enough for some needs. This reflects the 'early help' focus in the city.

The other main focus in the meeting was to input into and reflect on the Salford Ambitions for CYP EHWP - Gold Standard. One key part of this is that the LA has stated the ambition: "Voluntary and community sector capacity is developed and harnessed to support children's and young people's emotional health and wellbeing."

9. 0-25 Integrated Support Board

Date of Meeting: 10th June

The meeting focused on the Albion Locality pilot. A 'hackathon' event was held on 28th and 29th April. This enabled students from Albion Academy to meet intensively with members of the business community to develop innovative projects. The hackathon was called 'FACT Salford' (Fuelling Ambitions Creatively Together) and was held at The Landing, MediaCityUK. As a result of the two days of intensive work, five small teams of young people are working with the business community to develop the following projects:

- *Team Zeon*. An app to enable young people to book and use leisure and recreation facilities during quiet periods at discounted rates.
- *Vindictive Gamers*. A social gaming business that would generate income from publishing video content on gaming.
- *Chosen Generation*. A 'pop-up' youth club concept, bringing together young people from different backgrounds and faiths to socialise and plan young people's activities in a safe space.
- *Digibodies*. An app that encourages a healthy lifestyle by showing other young people the harmful effects of an unhealthy lifestyle on the body
- *Jobs4U*. An app that would allow users to access work experience opportunities and to learn about different types of jobs, either through watching content on the app or through finding a real world work experience opportunity.

A number of issues and opportunities are already emerging from this project, including:

- Behavioural insights: how can the projects be used to change people in the medium and longer term so that there is less dependence on and need for services in the future?
- Parental involvement: how can parents be meaningfully involved in the projects so that there is a 'trickle down' through the wider community and to ensure positive messages and insights are reinforced at home?
- Entrepreneurship. Many young people show the latent capacities to be entrepreneurs in the future. However, we don't have a pathway that prepares young people to be entrepreneurs (rather than to enter further education or to get a job). How could this be changed?
- Relationships/ services. Many of our young people don't lack 'services' what they lack is the networks and relationships that enable them to get on and forge new opportunities
- Aspiration/ resilience. Many of our young people are already hugely aspirational. What they lack is the resilience or grit to keep going when circumstances are tough and challenging.

A draft of the 2nd edition of the briefing newsletter for professionals regarding the 0-25 transformation was presented and is due for distribution shortly.
