CARBON REDUCTION PLAN GUIDANCE

Notes for Completion

Where an In-Scope Organisation has determined that the measure applies to the procurement, suppliers wishing to bid for that contract are required at the selection stage to submit a Carbon Reduction Plan which details their organisational carbon footprint and confirms their commitment to achieving Net Zero by 2050.

Carbon Reduction Plans are to be completed by the bidding supplier¹ and must meet the reporting requirements set out in supporting guidance, and include the supplier's current carbon footprint and its commitment to reducing emissions to achieve Net Zero emissions by 2050.

The CRP should be specific to the bidding entity, or, provided certain criteria are met, may cover the bidding entity and its parent organisation. In order to ensure the CRP remains relevant, a Carbon Reduction Plan covering the bidding entity and its parent organisation is only permissible where the detailed requirements of the CRP are met in full, as set out in the Technical Standard² and Guidance³, and all of the following criteria are met:

- The bidding entity is wholly owned by the parent;
- The commitment to achieving net zero by 2050 for UK operations is set out in the CRP for the parent and is supported and adopted by the bidding entity, demonstrated by the inclusion in the CRP of a statement that this will apply to the bidding entity;
- The environmental measures set out are stated to be able to be applied by the bidding entity when performing the relevant contract; and
- The CRP is published on the bidding entity's website.

Bidding entities must take steps to ensure they have their own CRP as soon as reasonably practicable and should note that the ability to rely on a parent organisation's Carbon Reduction Plan may only be a temporary measure under this selection criterion.

The Carbon Reduction Plan should be updated regularly (at least annually) and published and clearly signposted on the supplier's UK website. It should be approved by a director (or equivalent senior leadership) within the supplier's organisation to demonstrate a clear commitment to emissions reduction at the highest level. Suppliers may wish to adopt the key objectives of the Carbon Reduction Plan within their strategic plans.

¹Bidding supplier or 'bidding entity' means the organisation with whom the contracting authority will enter into a contract if it is successful.

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions for business mileage will decrease over the next five years to 1.543 tCO₂e by 2028. This is a reduction of 33%

This has been calculated on the basis of increasing the proportion of business miles undertaken by cycling and public transport and the increase in use of electric vehicles by employees for business mileage.

Further emissions targets will be developed on completion of baseline calculations.

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented from the 2022/23 baseline. The carbon emission reduction achieved by these schemes is in the process of being calculated. However, these measures will be in effect when performing the contract.

Completed actions (some predate our baseline year):

- Office waste recycling for paper, card, glass, cans, hard plastics, IT (longstanding)
- Promotion of car sharing for business trips (longstanding)
- Promotion of Cycle to Work Scheme (longstanding)
- Issuing of fleece jackets to staff to reduce use of secondary heating (longstanding)
- Carbon Literacy Training by environment lead (2019)
- Environmental Policy (2019)
- Production of Sustainable Procurement Policy (2019)
- Homeworking for all staff 1-2 days per week (2020)

- Board level commitment to development of a 'Net-zero by 2038 action plan' (2022)
- Purchase of vege/vegan meals only at business events (2022)
- Joined GM Business Green Scene – GM Chamber (2023)
- Received free sustainability and energy review consultation (2023)
- Completion of an Initial Environmental Review (2023)
- Staff awareness raising session at Away Day (2023)
- Establishment of an internal Environment Action Group (2023)

In the future we plan to implement further measures including:

- Completion of baseline emissions calculations for 2022/23 (2023/24)
- Development and implementation of Environmental Management Plan (2023/24)
- Staff awareness and behavioural change programme (2023/24)
- Composting collection for staff kitchen waste (2023/24)
- Explore replacement of heating system and fuel source with landlord (2023/24)
- Explore replacement/cost of fluorescent lighting units with landlord (2023/24)
- Explore options/cost for addition of secondary glazing with landlord (2023/24)
- Refurbishment of old courtroom to high environmental specification (2023-25)


This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.
